## **Student Instructions for Declaring an Endorsement**

Students should login to their Skyward Student Access account using the LISD network username and password. The link to Skyward Student Access is available under the Student Tab on the LISD Home Page.

- 1) Click the Endorsements link in the menu on the left.
- 2) Select the option "Declare and Endorsement".
- 3) Click the drop down arrow for the \*Declared Endorsement and select the option you choose.
- 4) Click the Declared Option drop down arrow if you wish to make an Option selection .
- 5) Be sure to check the box "I Agree" to indicate you agree to the terms of the Electronic Signature Statement.
- 6) Click the Save button at the bottom to complete the process.
