Annual Required Compliance Training

To meet state requirements, all LISD employees and contract staff are required to complete training **annually** on specific state-mandated topics. For your convenience, the required content is accessible in an eCourse entitled, Annual LISD Required Compliance Training, accessible from Eduphoria Workshop. Eduphoria Workshop requires an LISD username and password to log in.

The eCourse should take approximately 50 minutes to complete. A set of practice questions will follow each module, and a final assessment is required for course credit. Topics include, harassment, sexual harassment, respect for diversity, and bullying. The following required health-related topics are also included: accessing student health conditions, procedures for aiding a choking victim and preventing bloodborne pathogens, and awareness of life-threatening allergies, skin infections, and diabetes.

NOTE: This does not include substitutes. Supervisors of auxiliary or contracted staff in Custodial Services, Facility Services, Transportation, and Child Nutrition have received alternate instructions. If you have questions, contact your supervisor.

WINDOW:

The window for completing the course is June 8 through October 19, 2018.

REGISTRATION:

- 1. Go to <u>www.lisd.net</u>.
- 2. Click on Resources and select Staff.
- 3. Choose Eduphoria.
- 4. Log in using your district username and password.
- 5. Select the Workshop tab on the left.
- Select the credit type (at the bottom), 2018-2019 LISD Required Compliance Training (1),).
- 7. Select the course, LISD Required Compliance Training 2018-2019.
- 8. Select the Register (中) button at the top of the course.
- 9. After registering for the course, select My Portfolio under the Workshop tab.
- 10. Select LISD Required Compliance Training 2018-2019.
- 11. Select the Course Content tab to access and begin completing modules.

- Once ALL modules have a green checkmark (), you must select Request Credit (Request Credit) at the top of the screen. If you scored 80% or better, you will automatically receive credit for completing this course. Once credit is granted, the Request Credit button will change to Create Certificate (Create Certificate) for you to print a certificate for your records. YOU MUST SELECT THE "REQUEST CREDIT" BUTTON TO RECEIVE CREDIT.
