Dear AP Students and Families,

The College Board has made many changes to Spring 2020 testing. The College Board recently indicated that all tests will be conducted online. Lewisville ISD is scheduled to return to classes on May 4, 2020. We are currently working with the College Board to plan accordingly and will notify families as we learn new information.

The College Board is altering their testing process to allow students to take their AP exam from home. The College Board has stated the exams will be open book, but have put several safeguards in place to ensure academic integrity. Special Note for Calculus BC: Due to the change in format, the Calculus BC exam will not have a Calculus AB subscore. If students registered for Calculus BC and would rather take Calculus AB, please notify your Campus AP Coordinator by April 16th in order to change the test.

Portfolio Submissions: If your exam requires a portfolio, the College Board has extended the submission deadline until 11:59 pm (EST) on May 26, 2020.

Instructional Materials: The College Board is creating additional support materials, which can be found on the College Board web page or in Canvas at the link below. Testing at Home: Students must have access to an electronic device in order to test from home. A list of devices can be found at [Taking AP Exams Online – AP Coronavirus Updates](#). If you do not have access to internet or a device, please contact College Board at <https://collegeboard.tfaforms.net/74>

Students will receive a testing code for each registered AP exam via the email address listed in their College Board account. Students may also access their testing code by logging into their College Board account. If a testing code is not used during the primary testing exam window, the College Board will automatically provide a late testing code to those students.

Accommodations: If a student is approved for accommodations through College Board, the accommodation will be included in the link College Board sends for testing.

Refunds: The College Board is allowing for refunding of all tests as long as the testing code has not been utilized. If the testing code and the late testing code sent to your student are not utilized, you will be eligible for a refund. LISD will not be able to process refunds until we receive information from the College Board regarding which testing codes were utilized. We anticipate beginning the refund process in July 2020.

LISD is not allowing any new AP registrations. AP registration ended February 28th 2020.
