### PART I. GENERAL EXPECTATIONS FROM FEDERAL LAW

The Lewisville High School- Killough agrees to implement the following statutory requirements:

- The school will provide other reasonable support for parental involvement activities as the parents may request.

*Parental involvement means the participation of parents in regular, two-way, and meaningful communication involving student academic learning and other school activities, including ensuring—*

- (A) that parents play an integral role in assisting their child's learning;*

- (C) that parents are full partners in their child's education and are included, as appropriate, in decision-making and on advisory committees to assist in the education of their child;*
- (D) the carrying out of other activities, such as those described in federal law*

## **PART II. DESCRIPTION OF HOW SCHOOLS WILL IMPLEMENT REQUIRED SCHOOL PARENTAL INVOLVEMENT POLICY COMPONENT**

1. Lewisville High School- Killough will take the following actions to involve parents in the joint development of its school parental involvement plan:

- Minimum of three (3) PTA meetings held
- Parent Nights will be held to educate parents and students regarding the plan

3. The school will invite all parents of children participating in Title I, Part A programs to this meeting, and will encourage them to attend, by:

- Promotion via the Killough website, callout, Marquee, Facebook, and Twitter
- Parent letter (Weekly Smore) to promote meeting

4. Lewisville High School- Killough will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:

- Parent information meetings – Fall & Spring Open House
- Data review sessions for parents
- Information page/STAAR results sent home
- Callouts, Facebook, Instagram and Twitter

5. Lewisville High School- Killough will at the request of parents, provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

- The annual LHSK Goal Setting Process has been effective to increase parent communication and involvement.
- We will continue to work with parents to gather their input and increase opportunities for their involvement.
- Counselors will meet with at risk students to set goals and objectives to ensure their success

- STAAR report will be available online

7. Lewisville High School- Killough will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

- LISD Human Resources will provide parents with this notification in these circumstances.
- Administrator will send letter to parents to advise of changes

8. Lewisville High School- Killough will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --the state's academic content standards, the state's student academic achievement standards, the state and local academic assessments including alternate assessments, how to monitor their child's progress, and how to partner with teachers and campus staff:

- Orientation
- Open House – Meet the teacher
- PTA Meetings
- Skyward Family Access for monitoring of student's grade
- Canvas information from teachers
- Parental reminders emailed from Administrators

9. Lewisville High School- Killough will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

- Multiple parent meetings are held to discuss instructions on how to best utilize Skyward and Parent groups for Killough campus
