
28th Annual Dr. Martin Luther King, Jr., Contest 2020-2021 PHOTOGRAPHY

Eligible Participants: All Southern Denton County Students in Grades 4-12

Requirements: All work <u>must</u> be original and the title of your work must be the theme above. It should explore the impact of the theme on the daily life of people in society. It should also relate to Dr. King's ideals, philosophy, and principles.

The <u>original composition</u>, may be film or digital, color or B&W, <u>without</u> retouching. Please mount on poster board. Measurements should be a minimum of 9" x12" and maximum of 16" x 20". **Full Name** (w/phonetic pronunciation), phone, email, grade, school, and teacher's name must be written on the <u>back</u>. Please tape a 3"X5" card with an explanation of your work.

9th-12th grade group: 1st: \$150; 2nd:\$100; 3rd: \$75

6th-8th grade group: 1st: \$100; 2nd: \$75; 3rd: \$50

4th-5th grade group: 1st \$75; 2nd \$50; 3rd \$25

One entry may be selected as the \$250 Chairman's Prize.
