**Q – We’re going to respond to the Workforce Management component. Should we send a deviation if we want to respond? What format if not a full ERP?**

**Q – Would district entertain a 2-week extension?**

A – Companies and vendors should submit what they have at this time. No extensions are being entertained.

**Q – Marketplace question – have you had any demonstrations so far in last 6 months?**

A – No presentations have been done prior to the release of this bid.

**Q – Demo Dates – somewhat hard to get that scheduled – would you know when you would be communicating who will be called?**

A – We will turn around the requests very quickly (no specific date)

**Q – Three references – Cloud solutions are still fairly new to the marketplace so there would be limited number of vendors. Would you consider flexibility?**

A – Provide what references you can. We thought 3 would be a good foundation; we are looking for a good footprint and experience with school Districts – can be considered when received.

**Q – (Frontline) Who is the internal PM?**

A – iSphere.

**Q – (Frontline) Historical Data imports – what is the timeline?**

A – We want as much data as possible; we would need to evaluate with vendor. Other data related to Human Resources we may be looking to try to bring in.

**Q – (Frontline) Where is the data?**

A – On spreadsheets.

A – We will or provide later. We will want to understand how, what tools, hard limits.
