

Sianghngakchia nih Cohlanmi Thilhmaning Student Acceptable Use Policy

Lewisville Independent School District nih fimcawnnak caah aherhmi electronic chawnhbiak or pehtleihnak (electronic communication system) phun phun a chiah/tuah. **Hi electronic communications system timi hna cu the District's network (thilhri zam hau lomi wireless network tel chihin), servers, Computer in riantuannak hmun (computer workstations), mobile technologies, (computer thilri thilri herhmi –mouse, keyboard tbk (peripherals), applications, databases, online resources, Internet access, email, and any other technology designated for use by students, technologies thar a chuakmi vialte hna tel chihin) hna kh an si hna.** Cun sianginn ah um lio ah siseh, sianginn pawngah a ummi sianginn thilri (property) siseh, sianginn mawtaw (vehicles), sianginn nih tuah or bawmhmi (sponsored) cawlcanghna le sianginn campus kulh lengin alangin (remote) siseh Lewisville ISD electronics system na hman poah ahcun acunglei fiantermi ah aitel dihmi an si. Internet cu pehtlaihna/chawnhna (communication) phun tami le thawng thanhna (information networks) hna apetlaihermi (network) asi i, Web 2.0 resources (Blogs, Wikis, Podcasts, etc.) tbk an itel i, district's electronic communications systems aitelchihmi asi ti na theih aherh. Web 2.0 applications nih kumzabu 21th chawnh/pehtlaihna (21st Century communication, (tinmi hluchuah khawhna dingah riantuantinak (collaboration), fimmak lei thilthar tuahruah khawhna ding lamtha tampi a awnter. Kumzabu 21th sianginn cacawnnak (21st Century school system), technologies, Internet, and Web 2.0 um lo awk ah asi kho lomi aherh tukmi thil hna an si.

Hngakchia Internet Runvennak upadi (Children's Internet Protection Act) bantukin, Lewisville Independent School district ah riantuantu (staff) le sianghngakchia hna cu internet himbawm tein hmaning (rawlrlnak achuah lonak hnga), zeitindah online hmaning asi lai, email le Web 2.0 resources caah aitlak mi nuncan ziaza cawn piaknak siseh, online ah ngakchia caah zohdawh lo, upadi nih khammi (illegal), tihnung (harmful) le thil tha lo hna an zohkhawh lonak dingah khamtu-filtering technology le runvennak phun phun (protection measures) a hman or tuah hna. A himbawm le a ngandammi cawnnak pawngkam tha si khawhna dingah asi khawh chungin izuam a si ko nain, online ah zohdawhlo or aitlaklomi thil umnakah kal sual, kal hramnak in kham khawh dih bak timi cu asi kho lomi asi. **Cu caah internet hmanna kongah chiahmi phunglam (guidelines) siseh, aitlakmi le cohlan/pawm khawhmi in hman ding cu sianghngakchia poah i an rian le tuanvo asi.**

AITLAK OR ZOHDAWH IN HMANNAK CAAH GUIDELINESCHEU KHAT

- Sianghngakchia nih kau, zoh, remh (open, view, modify) ti lawng atuah lai i, amah pumpak file a simi cu computer chungin a delete (hlawnh) ta lengmang lai.
- Sianginn nih pekmi rian (assignments) le rian (projects) ca lawngah Internet hman ding.
- Sianghngakchia poah kha email pakhat cio le internet hman khawhna account (network accounts password) pek an si lai i, cacawnnak ca le sianginn nih nawl/sianh (permission) pekmi bantuk lawngin hman ding.
- Sianghngakchia nih thihpheih/tihnung (threatening) email catialmi le zohdawhlo/siarem lomi email ca (discomforting messages) a hmuh ahcun a saya te sinah chimh colh ding.
- Sianghngakchia nih district's electronic communications system, email, le wireless network access, and Web 2.0 tools/resources hna cu dawtnak le upatnak lawngin (kind and respectful) tonghtam or hman ding.

- Sianghngakchia cu district's electronic communications system a hmanna kongah amah bak lawng tuanvo (responsibility) a ngeih mi asi i, technology nih a duhmi poah atuahter/zohter khawh zong ah zohdawh le phungning te lawngin hman ding ah tuanvo angei fawn. .
- Sianghngakchia nih amah tein aikenmi technology thilri (on *Bring Your Own Technology*) LISD nih mileng (guest) caah chiahmi wifi access lawng a hman lai.

AITLAK LO (INAPPROPRIATE USE) HMANNING TAHCHUNNAK CHEUKHAT

- LISD nih chiah/tuahmi asi lomi thilhri-umlo pektleihnak (Wireless Hotspot) cu kham asi.
- Peng district's electronic communications system kha upadi nih duhlomi thil hna caah (illegal purposes) atanglei bantuk thil, hi vial lawng asi tinak si loin, internet hmangin mi cungah thatlonak tuah/tihram (cyberbullying) phaisa cawi in celhmi thil (gambling), nu le pa zohdawh loin ummi thil (pornography), le midang computer anmah theih loin awn le duhmi poah tuah (computer hacking) hna an si.
- Himbawmna (security) caah chiahmi thil monitoring or filtering or security measures hna riantuan kho lo dingin tuah or tuah izuam hna.
- Na user names and passwords midang he ihrawm or chimh (sharing)/or midang username, password ihlan, or midang account awn/kau piak.
- Timhciammam in sianhna (permission) um loin midang ta kau, zoh, hman le file pawl delete/hlawnh piak.
- Mah pumpak kong siseh, midang kong siseh (i.e., addresses, phone numbers, le hmanthlak online ah tar.
- Download tuah copyright ngeitu nawlpeknak um loin copyright tuahmi thawng/thil (information) fir/mah tuahmi/hmuhmi bantuk in chim (plagiarizing).
- Tinhchihnak he computer rungrul (virus) or adang tihnung (malicious programs) hna district's system chungah luhter/thlah.
- Upadi nih khammi (illegal), biachia, nu pa sualna lei thil, thihpheihnak, midang nek or hrangram in tinak tbk mi pakhat a limhang atlakter dingmi ca le thil hna online ah tial le tar.
- Nawlpek/sianmi ning loin khammi thilri hna kau le zoh or hman (restricted information or network resources).

Biapi mi (SPECIAL NOTE): CYBERBULLYING

Internet he aipehmi thilri (device) hmang in a dang sianghngakchia va t ihram, hrocer, hnahnawknak/zomhteihnak le thihpheihnak tuah hna kha (Cyberbullying) timi cu asi, or Hi thil hna hi an itel, sinain mahlawng hi an si tinak si loin:

- Biachia/dawhlo ca hna (abusive) cell phones, computers, or Internet-connected game consoles ah kuat.
- Biachia/dawhlo ca tial in (abusive) midang blog or social networking site (e.g., MySpace or Facebook) tbk ah tar piak.
- Midang minin social networking site or web page ser riang mang in kha pa or nu kha zohlangh/limhangthlaknak ah hman.
- Kha pa/nu (victim) nih midang kong kha biatha lo/chia tial bantuk in tuah in kha nu/pa kha minih kawm duh hna hlah seh tiin tuah.
- Kha nu/pa (victim) a umnak or aho asi theih khawhna ding akong –information-online ah tarnak thawngin kha nu/pa kha thinphang ding dirhmun or himbawm loin tuah.
- Interactive games (online in computer in celhmi game) icelh lio ah biachia or biathalo chimmi thlah.
- Mi pakhat kha atlin tein – cell phone camera in hmantlak, kha nu/pa mualphoh/thlaknak duh ah online ah tar (posting tuah).

AITLAK LO/NINGCANG LO HMANNAK NIH A CHUAHPI KHAWHMI THIL HNA (CONSEQUENCES FOR INAPPROPRIATE USE)

- Upadi le Sianghngakchia umtu ziaza ding (student code of conduct) he aitlakning in chimhhrinnak or tazacuai (legal action) nak le (arawkmi thil caah) phaisa liamternak zong a um kho.

- District’s electronic communications system hmanna nawl phihnak (suspension).
- District’s electronic communications system account(s) khar piak nak/or
- User Account phih piak thainak: Peng (district) nih aherh ati ahcun phungbuartu sianghngakchia kha district system hmanna nawl pek lo, or a chungthil cheukhat hman or zohnak nawl pek ti lo tbk tuah khawh asi.
- Tazacuai nak a phan kho (possible criminal action)

LAKHRUAKTHIL CAAH TIMHNAK (EMERGENCY PLAN)

Lakhruak thil a chuah or um tikah sianghngakchia nih 911 auh an duh ahcun anmah cell phones lawngin an auh lai. A dang phone auhnak poah cu AUP he aikahmi asi lai. Dirhmun/sinak, cawlcanghna, le thawngpang (official information) cu Peng (District) nih nu le pa le midang hna sinah chawnh biak pehtlaihna a tuah lai.

Electronic Communication Devices (she thilri): Nangmah technology rak iput (Bring Your Own Technology)

Nangmah technology te rak iput timi thawngin tuah khawhmi cawnnak thar (new learning opportunities) nih LISD kan tha an kan thawhter tuk. Sianghngakchia le cachimtu saya hna cu technology hmanna thawngin tuantina –collaborate le pakhat le khat cawnti (engagement) a ummi cawnnak an tem (experience) khawhna ding kha kan saduhthah asi. Sianghngakchia nih anmah technology (computer tbk) kha sianginn ah an rak iken in, sianginn ah le sianginn nih tuahmi cawlcanghna ah an hman khawh. Cathimtu saya nih cacawnnak caah aitlak ati tikah sianghngakchia nih hi electronics thilri pawl cu class chungah a hman khawh. Electornics thilri (devices) poah cu cacawnnak caah hman lo can poah ah deihter in (silent) adang te ah (put away) ding an si lai. Cacawn lo can (idinh can) or chuncaw ei can tbk ahcun sianghngakchia nih an electronics thilri pawl an hman khawh.

Electronics (devices) thilri timi hna cu notebooks, smartphones, iPhones, iPads, iPods, mp3 le eReaders hna an si. Thilri (devices) vialte cungah angeih tu sianghngakchia min pum (full name) tial ding. Sianghngakchia hna cu anmah le thilri (devices) cio tha tein zohkhenh kenkawi ding ah tuanvo an ngei. Devices vialte cu atha khat tein tun (charged) cia in Sianginn ah rak iken awk an si.
