This Student/Parent 1:X Use Agreement (the "Agreement") covers a device owned by Lewisville Independent School District (the "District") and assigned to my child with the following asset tag numbers: Serial Number: (the "Property").

Terms: I acknowledge and consent to pay a \$40 fee for the Replacement Benefit Program. For students who qualify for the National School Lunch and Child Nutrition Program the fee will be \$30. For financial hardships please contact the campus administration for payment options and reference the 1:X Student/Parent Handbook.

[THIS FEE COVERS ACCIDENTAL LOSS AND DAMAGE of the Property as defined in the terms of the LISD 1:X Student/Parent Handbook. The 1:X Student/Parent Handbook can be access at https://www.lisd.net/Page/13096 . The following coverage is provided by the Replacement Benefit Program:

ACCIDENTAL LOSS OR STOLEN DEVICE

- Covers a one-time replacement of the iPad and accessories, case, and keyboard.
- Lost or stolen devices must be reported within 5 business days.
- Any lost or stolen iPad will be reported to law enforcement and the iPad will be disabled by the district's management system. This will make the device unusable and nonfunctional.
- For circumstances in which a device is lost or stolen more than one-time, the full replacement cost of the iPad will be charged.
- For legacy equipment (older than iPad Pro 10.5), a charge will be assessed for the cost of the current replacement device.
- A fee of \$599 will be charged for the replacement of an iPad Pro 10.5.

ACCIDENTAL DAMAGE- iPad

- District issued iPads should remain in the district issued case at all times. If an iPad is damaged while in a non-District case, an additional \$35 fee will be charged.
- 1st Break- Covers a one-time iPad repair or replacement for accidental damage to the iPad
- 2nd Break- Covers a repair or replacement of a damaged iPad for a 2nd break with a \$50 copay
- 3rd Break or more of iPad- The full repair or replacement cost of the iPad will be charged
- For legacy equipment (older than iPad Pro 10.5), a charge will be assessed for the cost of the current repair or replacement.
- A fee of \$599 will be charged for the replacement of an iPad Pro 10.5
- NOTE: Any attempt to personally repair or schedule a repair outside of LISD will void the 1:X Replacement Benefit coverage and fees will not be reimbursed.

ACCIDENTAL DAMAGE, LOST, STOLEN- KEYBOARD

- 1st Incident- Covers the keyboard with a \$40 copay
- 2nd Incident- Covers the keyboard with a \$100 copay
- 3 or more incidents- The full replacement cost of the keyboard will be charged

If the Property is not in a District-provided case at the time of damage, an additional \$35 fee will be charged.]

I agree to pay the annual Replacement Benefit Program fee no later than the 3rd Friday after the 1st day of school and understand that the fee covers my liability from the date of payment to the beginning of the next school year. I further understand that the annual fee may be collected in advance of the

upcoming calendar school year when keeping a device already in my possession, and failure to renew the annual fee will terminate my participation in the Replacement Benefit Program and I will be required to return the device already in my possession.

I agree to comply at all times with the Lewisville Independent School District's Student/Parent 1:X Handbook and Student Guidelines for Technology Resources ("Acceptable Use Policy"). I understand that failure to comply with the terms of the handbook, guidelines, or policy identified above may result in the District reclaiming the Property from my child.

Title: Legal title to the Property is in the District and shall at all times remain in the District. I acknowledge that my child's use of the Property is limited to and conditioned upon my full and complete compliance with this Agreement, which includes the Student/Parent 1:X Handbook and Acceptable Use Policy.

Loss or Damage: If the property is intentionally damaged or is lost or stolen, I acknowledge and agree that I am responsible for the reasonable cost of repair or the current replacement cost of the device or comparable device as outlined in the Student/Parent 1:X Handbook. I understand that I must report loss of the Property to an administrator at my child's campus within five (5) business days after the occurrence, and if the Property is stolen, I must report that to the local police and provide a copy of the police report to an administrator at my child's campus within five (5) business days after the occurrence. I understand that if a lost or stolen device is NOT reported to the campus administrator within five (5) business days, my coverage under the Replacement Benefit Program is void. When a device is lost or stolen, I understand that the District may disable the device remotely to protect the device and/or data on the device.

Repossession: I understand that if I do not timely and fully comply with all terms of this Agreement, the Student/Parent 1:X Handbook, and Acceptable Use Policy, including the timely return of the Property, the District shall be entitled to declare you in default and come to your place of residence, or other place where the Property is located, to take possession of the Property.

Termination I understand that my child's ability to use the Property and coverage under the Replacement Benefit Program will terminate immediately at such time as my child is no longer enrolled in the District. I also understand that the District, at its sole discretion, may terminate this Agreement at any time by providing written notice to me at the e-mail address and/or physical address listed at the top of this form.

Appropriation: I understand that my failure to timely return the Property and/or the continued use of the Property for non-school purposes without the District's consent may be considered unlawful appropriation of the District's property, and the District reserves the right to pursue any remedies available under law.
