Eligible Participants: All Southern Denton County Students in Grades 4-12

Requirements: The <u>3-D</u> work including design, casting, and preparation must be done by the student without assistance, with supervision by Teachers as needed. Three-dimensional artwork must be no larger than 12" X 12" X 18" in total dimensions including an attached and secured base. If there is NOT a base, it must be sturdy and able to stand alone without other means of support. Artwork cannot exceed a weight of 20 pounds including the base. All parts of the artwork must be safely secured without protruding elements and be safe to handle. All work including casting must be done by the student without assistance. For ceramics, Greenware, oil-based clay, or unfired clay will not be accepted.

On the base/box, please affix a 3X5 card. On the card, we need your <u>printed</u> full name (w/phonetic pronunciation), phone number, email, grade, school, and teacher's name. You should write the story of the entry on this card. Items such as the circumstances of the art, its connection to the theme, and the message you wish to send to the viewers/judges should be included. [see additional rules below]
