

School Parental Involvement Policy

PART I. GENERAL EXPECTATIONS FROM FEDERAL LAW

The DeLay Middle School agrees to implement the following statutory requirements:

PART II. DESCRIPTION OF HOW SCHOOLS WILL IMPLEMENT REQUIRED SCHOOL PARENTAL INVOLVEMENT POLICY COMPONENTS

1. The DeLay MS will take the following actions to involve parents in the joint development of its school parental involvement plan:

- Parents are invited to work with the principal on this document
- Building Leadership Team is open to parents
- Surveys are sent to parents soliciting suggestions, constructive criticisms, and ideas for improvement

- DeLay Community Outreach activities like participation in LHS Hey Day, Homecoming in downtown Lewisville and holiday festivities in downtown Lewisville.

2. DeLay MS will take the following actions to involve parents in the process of school review and improvement under:

- PTA Board Meetings and General Meetings
- School contact information easily accessible on the school website
- Facebook and Twitter are constantly updated and are used as 2-way communication
- District and Campus Calendars are available to parents

3. DeLay MS will hold an annual meeting to inform parents of the school's participation in Title I, Part A programs requirements and the right of parents to be involved in Title I, Part A programs. The school will convene the meeting at a time convenient for parents and will offer a flexible number of additional parental involvement meetings, such as in the morning or evening, so that as many parents as possible are able to attend. The school will invite all parents of children participating in Title I, Part A programs to this meeting and will encourage them to attend, by:

- Expectations Day before school begins
- Fall and Spring Open Houses
- Parent Nights and Meetings - Middle School Parent Night, College and Career Night, AVID Parent Night, Parent Nights, Science Nights, School Report Card Meeting time available
- Opened the computer labs after school hours to parents several times through the year (most of these nights were used to complete on-line forms and reimbursable meal paperwork)

4. DeLay MS will provide parents of participating children information in a timely manner about Title I, Part A programs that includes a description and explanation of the school's curriculum, the forms of academic assessment used to measure children's progress, and the proficiency levels students are expected to meet by:

- Student Handbook provided and signed
- Skyward forms provided and available to complete at DMS
- Expectations Day where parents receive class schedules and information regarding school policy
- Progress Reports/Report Cards every 3 Weeks
- Letters signed by parents if students are in danger of failing
- Confidential Student Reports (STAAR) sent home
- School Report Card Meetings are held and open to the public once a year

5. DeLay MS will provide opportunities for regular meetings for parents to formulate suggestions and to participate, as appropriate, in decisions about the education of their children. The school will respond to any such suggestions as soon as practicably possible by:

- Callout system used to communicate consistently
- Facebook and Twitter used and updated most days
- Respond to voicemails and emails consistently
- Building Leadership Team monthly/bi-monthly meeting
- Parent/Teacher meetings always available by request
- Fall and Spring Open Houses

6. DeLay MS will provide each parent an individual student report about the performance of their child on the State assessment in at least math, language arts and reading by:

- All Confidential Student Reports are sent home to parents and a callout is created to parents whenever they are sent home

7. DeLay MS will take the following actions to provide each parent timely notice when their child has been assigned or has been taught for four (4) or more consecutive weeks by a teacher who is not highly qualified within the meaning of the term in section 200.56 of the Title I Final Regulations (67 Fed. Reg. 71710, December 2, 2002) by:

- LISD Human Resources will provide parents with this notification in these circumstances.

8. DeLay MS will provide assistance to parents of children served by the school, as appropriate, in understanding topics by undertaking the actions described in this paragraph --

- the state's academic content standards,
- the state's student academic achievement standards,
- the state and local academic assessments including alternate assessments,
- how to monitor their child's progress, and
- how to partner with teachers and campus staff:
 - Parent Nights with counselors available to discuss the literature provided on social/emotional topics
 - School Report Card Annual Meetings
 - Grade access to all parents through Skyward
 - CSRs sent home

9. DeLay MS will provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:

- Daily ACE Program through Communities in Schools
- Hosted on-line enrollment in our computer labs at 6 separate times
- iPads are provided to all students and parents have access to online grades with these devices daily
- DeLay Parent Nights hosts many topics supporting parent involvement and support, such as; AVID in LISD, Bullying in LISD - What Rights Do Parents Have, BYOT - What Does It Mean For Parents, Emerald Eagle Scholars of UNT - How Can My Child Go To College, Latino Family Access, Self-Harm - What Do Parents Need To Know, Parenting Strategies, Personal Finance, Drug Prevention Education, etc...

10. DeLay MS will, with the assistance of its parents, educate its teachers, pupil services personnel, principals and other staff in how to reach out to, communicate with, and work with parents as equal partners in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:

- PTA offered to all
- Building Leadership Team open to parents
- Multiple Parent Nights and opportunities for parent education provided
- Consistent communication
- Extra-curricular performance schedules provided

12. DeLay MS will take the following actions to ensure that information related to the school and parent-programs, meetings, and other activities is sent to parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:

- All of our communication with parents is provided and English and Spanish and some of our information is translated to Chin

- Parent Night General Sessions are performed in English and Spanish
