WORKERS' COMPENSATION TELEMEDICINE OPTION

We are pleased to announce the launch of a Telemedicine service available to injured employees as another option when seeking initial treatment following an on-the-job injury.

Edwards Claims Administration has partnered with RediMD who specializes in the delivery of Telemedicine for workers' compensation treatment. This service allows employees to schedule a doctor visit at their convenience (from work or home) with no travel and no waiting in potentially contaminated environments. Physicians are available 24/7, year-round. 24/7 triage services are available as well.

As most individuals carry smart phones, there is no special equipment or software necessary. Virtual visits may be handled via smart phone, tablet or webcam with a computer. All visits are facilitated through a simple link shared via text or email to the injured employee.

Opción de telemedicina para la compensación de trabajadores

Nos complace anunciar el lanzamiento de un servicio de telemedicina como otra opción que los empleados lesionados pueden usar cuando buscan tratamiento después de una lesión relacionada con el trabajo.

Edwards Claims Administration se ha asociado con RediMD, un especialista en la entrega de telemedicina para el tratamiento asociado con la compensación de trabajadores. Este servicio permite que los empleados programen una visita médica a su conveniencia (desde la casa o el trabajo) sin tener que viajar ni esperar en entornos potencialmente contaminados. Los médicos, además de los servicios de triaje, están disponibles las 24 horas del día y los 7 días de la semana durante todo el año.

Como la mayoría de personas lleva teléfonos inteligentes, no es necesario ningún programa o equipo especial. Se pueden manejar las visitas virtuales por teléfono inteligente, tableta, o cámara de una computadora. Todas las visitas se facilitan a través de un simple enlace compartido por mensaje de texto o correo electrónico al empleado lesionado.

Solo se toma una simple llamada telefónica para iniciar el proceso:
