**SUBJECT:** Marcus HS - IAQ - Air Test Results - 14 Rooms

On Wednesday 10/18, Apex-Titan Air tested the 14 Rooms. It is typically assumed that indoor spore levels in an area with filtered or air conditioned air, and activity levels associated with schools average below the outdoor levels. Data from the airborne fungi sampling indicated that the total indoor concentration of mold/fungi in Room D-102 (Conference Room), was **7.8%**, Room D-102 (Principal's Office), was **12.1%**, Room D-102 (Secretary's Office), was 8.5%, Room D-102 (Business Office), was 19.8%, Room D-103, was **26.6%**, Room D-106, was **1.7%**, Room D-108, was **6.9%**, Room D-110, was **5.1%**, Room C-102, was **6.0%**, Room C-104, was **2.6%**, Room C-106, was **16.4%**, Room C-108, was **5568.0%**, Room C-109, was **9.4%**, Room C-110, was **1339.4%**, of the outdoor levels. Utilizing this theory, the indoor concentrations in Rooms C-102 (Conference Room), Room D-102 (Principal's Office), Room D-102 (Secretary's Office), Room D-102 (Business Office), Room D-103, Room D-106, Room D-108, Room D-110, Room C-102, Room C-104, Room C-106, Room C-109, are within the acceptable guidelines for areas with filtered air or air conditioning. **Rooms C-108** and C-110 are high with Aspergillus/Penicillium. Apex Titan and I will be doing further inspection in those two rooms. If you have any questions, please call me.
