The 2022-23 school year calendar has embedded PLC and work days this year to provide more time for staff to complete critical aspects of their job. Please see below for the description and timing of the different days.

Embedded Professional Learning / Work Days			
Staff Work Day	Time allotted for staff to complete tasks and prepare for students. This time is free from structured meetings. Tasks might include but are not limited to: grading papers, conducting parent conferences, preparing materials, collaborating with specialists, and updating lesson plans.		
PLC Time	Time allotted for professional staff to collaborate in learning communities to learn, reflect, and prepare for students. This time is structured and expectations are communicated by campus admin. Tasks might include but are not limited to: analyzing data, reviewing curriculum, discussing instructional practices, learning new strategies, and engaging in effective lesson design.		
Trade Day	Learning is chosen by employees that pertains to their work content, skill levels, and interests as well as the flexibility of format and time that works best for them. Proper documentation must be obtained and learning must occur outside of contract days/hours.

# Staff Professional Learning Days - Professional learning format will be based on the organizational guidelines and protocols being followed at that time.

The professional learning days in August do not require waivers from the state; therefore we have a little more flexibility. Any team building activities or outings need to occur in August, with approval by your chief. Team Building outings per campus will not be approved two years in a row. Please attach a professional learning day agenda to the Eduphoria course. \*Please ensure that social media postings reflect the hard work that teachers engage in to prepare for the start of school.

### **Early Release Days**

There are 3 student early release days on the calendar, October, March, and May. This year, all three early release days will be staff work days. All staff are expected to work the full day and leave at the end of their regular contract day. \*Early release days will be reviewed and analyzed each year for usage and intent.

### **Trade Days**

All LISD staff hired prior to November 21 have 12 hours of learning to complete to count towards trade credit. All trade credit learning must align with the professional learning defined in the chart above and meet trade credit requirements of occurring *outside of contract days/hours*. Trade days do not count towards minutes of instruction. 12 hours of learning must be completed and submitted for credit by March 31, 2023.
