Current 8<sup>th</sup> Grade Students, Parents, Guardians,

In preparation for the 2019-2020 school year, LISD is requesting current proof of residency for all 8<sup>th</sup> grade students. Texas Education Code 25.001 (b) enforces proof of residency for a school district. A student must reside within LISD boundaries to attend any LISD school. LISD does not accept any phone (home or cell) bills or cable/satellite bills. **LISD will only accept electric, water and natural gas bills as proof of residency (due date of April 1 or later).** If the apartment you live in pays all utilities, a copy of your lease will be accepted; make sure that your name and the student's name is on it.

If you already obtained an approved transfer from Community Services for the 2019-2020 school year, you only need to send a current utility bill.

**If the utility bills are in the name of someone other than the student's parent/legal guardian, a Residency Letter from LISD Community Services is required.** \*

If no proof of residency is turned in by **May 10<sup>th</sup>**, your student's class selection will **not** be entered into Skyward and they will not receive a schedule in August. Any classes held for your student will be released back into the pool for other students to select.

**Please make sure to write your student's name and ID# on the utility bill.**

El Código de Educación de Texas 25.001 (b) hace cumplir el requisito de presentar un comprobante de domicilio para el distrito escolar. El estudiante tiene que residir dentro de los límites de LISD para asistir a una escuela del Distrito Escolar. LISD no acepta recibos de teléfono (casa, o celular) ó de cable. **LISD sólo aceptará recibos de electricidad, agua ó, gas (con due date of April 1 or later).** Si el complejo de apartamentos en el que vive paga todas las utilidades, el contrato de su apartamento será aceptado, pero tiene que incluir el nombre de usted o del estudiante.

Si usted ya tiene un traslado aprobado para el año escolar 2019-2020, solo necesita enviar un recibo de utilidad actualizado.

**Si los recibos de utilidades están a nombre de alguien más que no sea del padre o tutor legal del estudiante, necesitará adquirir una carta de residencia en el Departamento de Servicios de Comunidad del LISD. \***
