Construction Update Questions	Response
When will the Career Center be completed?	August 2020
Are we able to save any of the large trees in front of Purnell?	All of the large trees directly along Purnell Street are shown to remain. Of the 13 total trees on the North side of the existing Purnell Support Center, 11 are shown to remain and 2 are shown to be removed for the construction.
Can any of the bricks from the old Purnell building be given away?	We would like to offer some memorabilia in the form of bricks, etc. for folks in the community since this facility has some sentimental value as their old HS. We will need to investigate this.
Do the demographics still support opening Josey ES in the original timeline?	The current demographics show that the school will not be needed until one year later than originally planned.
Where would the students for Josey ES go during the delay?	The students would remain at the campuses they are currently zoned for until the new school boundaries are approved by the Board and Josey ES is complete.
Do we study the traffic and drop off patterns on the new school designs?	Yes, much thought goes into the design of every new school site with careful consideration to parent and bus drop-off as well as parking.
Have we considered a sky bridge in front of Hedrick MS for the students to cross over the driveway?	No, a sky bridge is not included with Hedrick MS.
Security Update Questions	
Will there be criteria for denying or allowing visitors to be buzzed in at the front doors?	Guidance will be developed for campus office staff.

Huffines MS currently has a window film in their vestibule making it impossible to see directly into the school. Did we add this on all of the new security vestibules?	No, we are not currently installing frosting or opaque film on the vestibule glass.
Do the Principals know about the Security Vestibule project?	Yes, all principals have been informed about the project.
Will Tom Hicks ES have the added door buzz-in component to the main office?	Yes, all of the new security vestibules will have the same components.
Is there any State funding available to the District for security?	We are closely monitoring the legislative session in Austin for increased funding and potential state/federal grants for school safety.
Do all of our cameras also have audio?	Only approved cameras in special education classrooms have audio capabilities as required by state law.
Technology Update Questions	Response
Were the device sales better than expected?	<p>YES. The total amount of revenue collected through the residual value project was higher than originally anticipated. We conservatively estimated that we might anticipate the resale value to be approximately \$2.2 million over the 5-year period. However, good news, we received \$2.4 million for this year alone! Of course, this year did include the largest amount of inventory for residual value...</p> <p>Considering this was the first time LISD did a large mobile device refresh, we did not have any specific expectation for the number of devices that were directly sold back to the community. The latest data we've been provided, as of 12/14/2018, is that 367 devices were sold through their portal set up for the LISD Community.</p>
Did we offer a reduced price for devices that did not have a charger or cord? If not, then why do	The company that was awarded the contract for the residual value of the used Apple devices determined the cost for the resale of the

<p>we charge families when those items are not returned?</p>	<p>devices. In fact, the purchase of these used devices was through this company and NOT LISD. From our understanding, the devices were re-sold with charging cords/accessories. LISD did provide these accessories to the vendor as expected by the contract. In addition, considering over 15K iPad Airs were repurposed, it was important we made sure all accessories were accounted for since the chargers and cords would be needed for those devices. LISD continues to take great effort to ask students to be responsible for the hardware and accessories that are issued to them, part of this effort includes communication with students and parents to return all hardware and accessories that are provided to them.</p>
